## Sub.: Information for Rajasthan Govt. Health Scheme (RGHS) for the F.Y.2022-23.

Medi-Claim Insurance Policy of RVUN is going to be expired in near future. The Board of Directors, RVUN in its 308<sup>th</sup> meeting has accorded its approval regarding implementation of RGHS in the company w.e.f.01/04/2022 for the employees appointed on or after 01/01/2004. For this, it is mandatory to provide details of employees to the SI&PF department.

It is, therefore, requested to make available consolidated and entire information of **all employees recruited on or after 01/01/2004** of your project/unit in soft copy (Excel Sheet) as well as in hard copy in the requisite format **latest by 16/03/2022** positively, considering the following :

1. Information of Officers as well, irrespective of the fact that their salary is being prepared at H.O. Level.
2. Information of RVUN employees, who are on deputation to other RVUN project.
3. Information of RVUN employees, who are on deputation to outside RVUN (*mentioning Department Name*), but not receiving any Medical Facility there. The concerned Project authority shall ensure the recovery of monthly subscription from their salary.
4. Information of outside RVUN employees, who are working in RVUN and to whom RGHS Facility is to be given by RVUN, as per terms & conditions of their appointment.
5. If any employee faces any problem in making RGHS Card, then also information of that employee shall be included, leaving the RGHS Card column blank.
6. Information of newly joined employees during the F.Y. shall be submitted in the same format as soon as they join the services in the Nigam.
7. Employees who are covered under ESI and likewise health schemes shall be *excluded*.
8. Certificate that all the employees of unit/office, which are to be covered under RGHS, have been included in the provided information.
