QUALIFYING REQUIREMENT

The firms participating in the tender enquiry should fulfill the following qualifying requirements:-

1. The participating bidders should have Service tax registration with central Excise Department, PF registration, PAN card, ESI registration and labour license (if required).
Or
In case of any registration presently not available with the participating firm / bidder then they are required to furnish an undertaking on Rs. 100/- Non Judicial Stamp Paper duly attested by Notary Public that the required registration shall be obtained by them & furnished to RVUN within one month after placement of LOI.
2. The bidder shall furnish the solvency of Rs. 10.0 Lacs or above and it should not be more than two year old from the date of tender opening.
3. The bidders should have at least one year similar experience in providing hired vehicles to any Govt. / Industrial organization / Power station.
4. The bidder should submit an undertaking on non Judicial Stamp Paper worth Rs. 100/- with the certificate mentioning in it that the firm has no liability in the concerned department regarding deposition of C.P.F, E.S.I, Service tax etc. up to the period 31.03.2016.
