Requisite processing fees should reach on or before schedule date and time at the office of the Superintending Engineer (Proc.), Opposite new Power House, Indira Colony, Barmer by DD But Tender fees & EMD can be deposit by DD or directly in our collection account a/c 00000061069403950 IFSC Code SBIN0031174 of Account Officer(GLTTP)RVUN Ltd Barmer with prior intimation .Without Requisite tender cost, EMD and processing fees tender will not open.

PQR for TN-489 (Civil)

1. The bidders should have average Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less than the amount calculated on prorata basis for 12 months of the total estimated value of the work or be at-least 50% of the total estimated value of the work, whichever is higher.

Or

Solvency will be more than estimated value issued by nationalized bank or competent authority and old not be more than three years from date of publishing.

2. The bidder should have an experience of having successfully completing similar works during last 7 years ending last day of the month previous to the one in which applications are invited and should be either of the following :-
 - a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
or
 - b. Two executed/completed contracts , as above, costing not less than the amount equal to 50% of the estimated cost each
or
 - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. The participating bidders should have GST registration , PF registration, PAN card, ESI registration and labour license (if required).
4. The bidders should submit Satisfactory performance certificate/work completion certificate for similar nature works executed by the firms and these should be signed by the order placing authority of the concerned organization and performance certificate for GLPL works issued on or after dated 01.11.2018 should be signed by the concerned Chief Engineer/Incharge of power station/project.
5. The bidders should submit an undertaking on Non – judicial stamp paper worth Rs. 100/- on original stamp paper (Photo copy will not be accepted) with the certificate mentioning in it that the firm has no liability in the concerned department regarding deposition of CPF , ESI & Service Tax/ GST etc. upto the period **31.03.2018**.

PQR for TN-490(L&L)

1. The bidder must have an experience of having successfully executed / completed the works of uprooting of wild vegetation and cutting/ trimming of trees in any thermal power plant(s) /industries during last 7 years ending last day of the month previous to the one in which applications are invited and should be either of the following :-
 - a. Three similar completed works costing not less than Rs. 2.6 Lac each W.O.

or

b. Two similar completed works costing not less than Rs. 3.5 Lac each W.O.

or

c. One similar completed works costing not less than Rs. 5.13 Lac each W.O.

2. The "Similar work" means the bidders should have experience of the works of uprooting of wild vegetation and cutting / trimming of trees in any Thermal Power plant / Industries.
3. In support of the above, bidder shall furnish documentary evidence , copies of work order along with Satisfactory performance certificate/ Work completion certificate for above works executed by firm issued by owner /order placing authorities. In case of works awarded by by RVUN performance certificate issued on or after 06.01.2017 should be signed by the Superintending Engineer / In charge of power station / project.
4. The word "executed means that the bidder should have achieved the progress specified in the QR even if the total order is not completed / closed. The same shall be supported by documentary evidence issued by the order placing authority/owner.
5. The bidders should have average Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less than 5.13 Lac.

Note:-

- a. other income shall not be considered for arriving at annual turnover.
- b. In support of Annual turnover, Bidder shall furnish annual reports /copy of audited P&L account and balance sheet . In cases where audited results for the last preceding financial year are not available , certification of financial statements from a practicing Chartered Accountant shall also be considered acceptable.
6. The bidders should have GST registration , PF registration, PAN card, ESI registration and labour license (if required)
7. The bidders should submit an undertaking on Non – judicial stamp paper worth Rs. 100/- on original stamp paper (Photo copy will not be accepted) with the certificate mentioning in it that the firm has no liability in the concerned department regarding deposition of PF , ESI & Service Tax/ GST etc. upto the period **31.03.2018**.
8. Solvency of reputed bank having minimum 6.0 lacks.

Note: - 1.The technical evaluation of the bids shall be done on the basis of above criterions. The offers of the bidder not fulfilling above conditions fully or partially are likely to be ignored& rejected.

2. In compliance to Rajasthan transparency in public procurement Act 2012 and Rajasthan transparency public procurement rules 2013 the A to D annexure has been add in GCC. These will be part of GCC of contract .The bidders should go through these. The bidder should fill the annexure
