2. Eligibility Criteria

The bidders participating in the tender enquiry should fulfill the following qualifying requirement.

1. The participating bidders should have GST registration with Central Excise Department, PF Registration, Electrical License, PAN Card, ESI Registration/Undertaking and Labour License (If required).
2. The bidder should have executed the repairing work of DEC make 600MW or above generators alongwith dismantling and assembly of retaining ring of generator rotor at site during last seven (07) years in any Thermal Power Stations as on the date of bid opening as per below:-
 - i. Single work contract of value not less than 1.28 Crore.
 - OR
 - ii. Two work contract of value not less than 0.80 crore each.
 - OR
 - iii. Three work contract of value not less than 0.64 crores each.

3. The bidder should furnish satisfactory, performance certificate of above work duly signed by the Order placing authority of concerned organization.
4. The average annual turnover of the bidder, during last three (03) years ending of 31st march of the previous financial year should be at least 100 % of estimated cost. For this purpose any one of the following documents may be submitted:-
 - i. Audited balance sheet of last three financial years
 - ii. Annual return filed with Income Tax Department/ TDS Certificate of last three financial years
 - iii. Copy of executed work orders.
