### **QUALIFYING REQUIREMENT**

The bidders participating in the tender enquiry must fulfill the following qualifying requirements. The documents in support of qualifying requirements shall be submitted along with Part-A Bid:-

- a) Bidder should be a Company/ a proprietorship/ a partnership firm/limited liability partnership firm / or a Joint venture company / SPV.
- b) The average annual turnover of the bidder for the last three financial years ending on 31.03.2019, should be at least 30 Crores.

**Note:**

1. In case of partnership firm /LLP, partners jointly together or as a firm must meet the eligibility criteria stated in point 'b' above.
2. In case of Joint venture/co- venture/SPV, members of Joint venture/co-venture/stake holders of SPV severally or jointly must meet the eligibility criteria stated in point 'b' above.
3. Audited balance sheets duly certified by the Chartered Accountant showing the business turnover and profit & loss account should have a membership number.
