Point no. 02 of PQR of the TN-2618 (FF) has been revised and new point no. 02 of the PQR is mention below:-

New point no. 02 :-

The bidder must have an experience of Fire Fighting Operation/Maintenance is required. The bidder should have experience in Operation/Maintenance of fire fighting system of high rise building comprising of hydrant system, sprinkler system, Fire alarm system, Electric/Diesel driven pumps and various types of extinguishers, in any of the thermal power plant(s) / gas power plant(s)/ any process industries/any electrical utility/organization during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):

- a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
or
- b. Two executed/completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each
Or
- c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.

PRE- QUALIFYING REQUIREMENT (PQR) FOR ONE YEAR CONTRACT PERIOD

NAME OF WORK:- ONE YEAR CONTRACT FOR THE WORK OF FIRE FIGHTING OPERATION FOR 6X250 MW (UNIT-1 TO 6), SSTPS, RVUNL, SURATGARH.

Only those firms can participate, who possess the following pre-qualifying requirements and shall have to submit necessary documents along with tender.

1. Average Annual Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less than Rs 38,69,000/- (i.e 100 % of the total estimated value of the work).
2. The bidder must have an experience of Fire Fighting Operation/Maintenance is required. The bidder should have experience in Operation/Maintenance of fire fighting system of high rise building comprising of hydrant system, sprinkler system, Fire alarm system, Electric/Diesel driven pumps and various types of extinguishers, in any of the thermal power plant(s) / gas power plant(s)/ any process industries/any electrical utility/organization during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):
 - a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
or
 - b. Two executed/completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each
or
 - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. Satisfactory performance certificate or satisfactory work completion certificate for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization. In case of works awarded by RVUN performance certificate issued on or after 06.01.2017 should be signed by the chief Engineer/In charge of Power Station/Project.
4. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour license (if required) and class A electrical license (if required).

Note:- The technical evaluation of the bids shall be done on the basis of above criterions. The offers of the bidder not fulfilling above conditions fully or partially are likely to be ignored.
