#### 3. ELIGIBILITY CRITERIA

In addition to the requirements stipulated in other clauses, following shall also apply:-

3.1 The bidder should be either manufacturer or authorized dealer / distributer of network printers and should have experience of having successfully executed / completed supplies of network printers for any government organization / PSU / NTPC within preceding 07 (seven) years ending last day of the month previous to the one in which bids are invited with either of following:-

One purchase order of value not less than Rs. 18.00 Lakhs, OR Two purchase orders each of value not less than Rs. 11.00 Lakhs each, OR Three purchase orders each of value not less than Rs. 9.00 Lakhs each.

- 3.2 The average annual turnover of the bidder in the preceding three (3) financial years as on the date of Techno-commercial bid opening shall not be less than Rs. 46.00 Lakhs. (Indian Rupees Forty Six Lakhs only).
- 3.3 Bidder shall submit documentary evidence being OEM or in case of authorized dealer / distributor, bidder shall submit MAF from OEM as per prescribed format.

#### Notes:-

- (i) The word 'executed' mentioned above means that the bidder should have achieved the criteria specified above even if the total contract is started earlier and/or is not completed/closed. The same shall be supported by documentary evidence issued by the Owner / end-user of that plant.
- (ii) In case of orders under execution, the value of work executed till the date of opening of Techno-commercial bid proposal as certified by the Owner/end-user shall be considered.
- (iii) Other income shall not be considered for arriving at annual turnover.
- (iv) Bidder shall submit the copies of PO & proof towards execution of supplies as per QR.
- (v) Bidder shall submit financial statement such as balance sheet, profit and loss account, turn-over certificate etc. of preceding three (3) financial years as on the date of Techno-commercial bid opening duly certified from Practicing CA.
- 3.4 Consortium of firms is not eligible to bid. Further, the selected bidder shall not assign or sub-let his contract or any substantial part thereof to any other agency.
- 4. The proof / supporting documents of the PQR must be uploaded in technical bid, failing which their bid will be summarily rejected.
- 5. The bidder will have to register themselves on website http://www.eproc.rajasthan.gov.in for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.
- 6. Interesting bidders will download & submit their techno-commercial bids on e-procurement portal only and technical bid & evaluation shall also be done on e-procurement portal. Thereafter, price-bids of qualified bidders shall be opened on e-procurement portal.

- 7. The tender for supply shall remain valid for the period of 120 days from the date of opening of technical bid.
- 8. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.
- 9. All tenders, in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totalling or discrepancies in figures or words or other discrepancies, may be liable to rejection.
- 10. Conditional tenders shall not be accepted and will be liable to be rejected.
- 11. The department will not be responsible for any delay on account of late submission of tender due to online submission.
- 12. Physical submission of bids is not allowed.
- 13. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
- 14. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
- 15. Tender fee / cost and e-tender processing fee are not refundable in any condition.
- 16. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
