3. ELIGIBILITY CRITERIA

In addition to the requirements stipulated in other clauses, following shall also apply:-

Technical Criteria:-

3.1 (i) The bidder should be a manufacturer of coal pulverizers and should have supplied Ball & Tube Pulverizers to at least 2 (Two) coal fired Units, each of 200 MW or higher capacity, located at two different power stations and which have been commissioned at least two years prior to the date of bid opening with the same type of Grinding Balls (Forged Steel / Hi-chrome / Ceramic inserted / Low alloy Cast Iron / Manganese steel etc.) as offered by the bidder.

OR

3.1 (ii)(a). The bidder should be a manufacturer of grinding balls of types (Forged Steel / Hi-chrome / Ceramic inserted / Low alloy Cast Iron / Manganese steel etc.) offered by him.

AND

(b). Bidder should have executed orders for Grinding Balls of same type as offered by him during last seven (7) years from the date of technical bid opening in any of the following mode:-

- i) Single order with quantity of at least 1445 MT, OR
- ii) Two orders with quantity in each order not less than 900 MT,

AND

(c). The bidder's manufacturing & testing facilities should include following:

Manufacturing facilities:-

- (i) Induction / cupola / Induction Arc Furnace for melting iron
- (ii) Casting / Moulding (for cast Balls) / Forging facility (Forged Balls)
- (iii) Heat Treatment facility

Testing facilities:-

- (i) Hardness tester
- (ii) Microscope of desired magnification to clearly validate the microstructure
- (iii) Spectrometer

3.2 The bidder should have executed orders for coal pulverizers /Grinding Balls of same type as offered by him during last seven years to any Thermal Power Plant during last seven (7) years prior to the date of techno-commercial bid opening as below:-

- (i) At least One order of value not less than Rs. 1250 lakhs, OR
- (ii) Two orders, each of value not less than Rs. 780 lakhs, OR
- (iii) Three orders, each of value not less than Rs. 625 lakhs

Note:- The word 'executed' means that the bidder should have achieved the progress specified in the above para even if the total contract/order is not completed/closed. The same shall be supported by documentary evidence which should be duly acknowledged by consignee/end user of concerned Plant.

Financial Criteria:

The average annual turnover of the Bidder in the preceding three (3) financial years as on the date of techno commercial bid opening shall not be less than Rs. 13.40 Crores (Rupees Thirteen Crores Forty Lacs only).

Note:-

- (i) Other income shall not be considered for arriving at annual turnover.
- (ii) In cases where audited results for the last financial year as on date of techno-commercial bid opening are not available, the financial results certified by a practising chartered accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practising chartered accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO stating that the financial results of the company are under audit as on the date of techno commercial bid opening.

- 4. The proof / supporting documents of the PQR must be uploaded in technical bid, failing which their bid will be summarily rejected.
- 5. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.
- 6. Interesting bidders will download & submit their techno-commercial bids on e-procurement portal and technical bid & evaluation shall also be done on e-procurement portal. Thereafter, price-bids of qualified bidders shall be opened on e-procurement portal. Please note that if qualified bidders are more than two, Plant-wise Reverse Auction (separately for each plant on total FOR Site price) on different portal (ITI Portal) shall be carried-out among qualified bidders and contract may be awarded to the plant-wise L-1 bidder having lowest FOR Site price of respective plant after Reverse Auction. However, if qualified bidders are less than

three then to ensure effective competition, RVUN may cancel the Reverse Auction and contract may be awarded to L-1 bidder of respective power plants as per prices quoted in price-bids or on negotiated prices. All participating bidders will have to register themselves on ITI portal for participating in the Reverse Auction against this tender.

7. The tender for supply shall remain valid for the period of 120 days from the date of opening of technical bid.
8. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.
9. All tenders, in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totalling or discrepancies in figures or words or other discrepancies, may be liable to rejection.
10. Conditional tenders shall not be accepted and will be liable to be rejected.
11. The department will not be responsible for any delay on account of late submission of tender due to online submission.
12. Physical submission of bids is not allowed.
13. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
14. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
15. Tender fee / cost, e-tender processing fee and Registration Fee for Reverse Auction Portal are not refundable in any condition.
16. All other conditions shall be prevailing as detailed out in the departmental tender document (in the respective sections/ volumes).
