Online tenders are invited by Dy. Chief Engineer (TD-II), Rajasthan Rajya Vidyut Utpadan Nigam Limited, Room No. 307, 3rd Floor, Vidyut Viniyamak Bhawan, Sahkar Marg, Jaipur-302005 for **"Supply of 01 no. Bull Dozer including standard accessories and standard tools & tackles etc. along-with 01 No. 100T Hydraulic Jack and AMC for a period of 3 years after completion of warrantee period for 2 x 250 MW, Unit#1 to 4, CTPP, Chhabra"**.

The scope includes design, engineering, manufacture, assembly, testing and inspection at supplier's works, packing, dispatch, supply, transportation to site, insurance, delivery at site, receipt, unloading, handling, storage, installation, pre-testing and commissioning and handing over of 01 no. Bulldozer with coal blade at CTPP, Chhabra. Further detailed scope of work, specifications and terms & conditions are given in the tender documents.

Please note that it is mandatory for every participating bidder to submit the original DD/BC, print out of payment details of NEFT/RTGS/IMPS against tender fee / cost, e-tender processing fee and EMD in physical form in the office of Dy. CE (TD-II), RVUN, Jaipur within scheduled date & time as mentioned in the NIT, otherwise technical bid will not be opened even-though they have uploaded the copies of the same on E-tender portal. Further, scanned copy of above should also be uploaded on e-procurement website <http://www.eproc.rajasthan.gov.in> under Cover-I.

2. ELIGIBILITY CRITERIA

In addition to the requirements stipulated in other clauses, following shall also apply:-

Technical Criteria:-

The Bidder should be a manufacturer and should have supplied at least 01 no. of Bull Dozers crawler mounted (mechanical governing type) with coal blade with capacity of minimum 15m³ to any of the Thermal Power Stations / coal mining fields in India, for handling coal during the last five years.

In support of above, bidder shall submit the following documents:-

- (i) Copies of the Purchase Orders for the supplied Dozers
- (ii) Satisfactory Performance Certificate for at-least 01 no. Bulldozer (from the above supplied bulldozers) from the end user (from In-charge of end-user plant/unit) that the above Bull dozers are in continuous operation for a period of more than 2 years as on the date of bid submission.

- (iii) The Bidder should have well equipped facility for attending major breakdown of equipment and schedule maintenance of supplied Dozers.
- (iv) The Bidder should be a Company under the (Indian) Companies Act 1956 or under the laws of any other jurisdiction (for overseas companies) and should be manufacturing Dozers for a period of more than 5 years as on the date of bid submission.

Financial Criteria:-

- (i) The Average annual turnover of the bidder in the preceding three financial years as on the last date for bid submission shall not be less than Rs. 6.00 Crores (Rs. Six Crores).
- (ii) The Bidder shall submit the audited balance sheet, profit and loss account for the last 3 (three) consecutive financial years.

General:-

- (i) Manufacturer should have permanent service facilities in India for technical support & supply of spare parts and should be capable to provide spares & services for a period of at-least 10 years from the date of supply.
Further, in case of Indian authorized dealer of foreign manufacturer, the manufacturer shall have to issue a certificate / undertaking that the above authorized dealer / channel partner is their genuine authorized dealer / channel partner in India and capable of supply & commissioning of bulldozers manufactured by them including technical support & supply of spares for a period of at-least 10 years from the date of supply. Further, manufacturer should also undertake that in case, authorized dealer/channel does not provide the above, then same shall be provided by manufacturer.
- (ii) For the above, an undertaking on non-judicial stamp paper worth Rs. 100/- shall be submitted by the manufacturer in the bid documents. The Bidder should have a service centre in the vicinity of India to attend any calls in a short period of time.

In case of foreign manufacturer; Indian authorized dealer / channel partner may also be allowed to participate in the tender. In this case:-

- (a) The authorized dealer / channel partner shall submit a letter from the manufacturer with a specific request to allow them to participate in the tender on behalf of the manufacturer & the manufacturer must stand technical support and guarantee for the material supplied.
 - (b) In addition, any authorization given by the manufacturer for a specific tender shall not be considered for evaluation.
 - (c) The authorized dealer / channel partner shall submit the documents from the manufacturer to fulfil the above Pre-qualifying Requirements of the tender.
 - (d) If the authorized dealer / channel partner fails to execute the order, the manufacturer along-with the authorized dealer / channel partner would be liable for blacklisting.
3. The proof / supporting documents of the PQR must be uploaded in technical bid, failing which their bid will be summarily rejected.
 4. Bidders not fulfilling qualifying requirements are advised not to submit their offer against this bid specification. The offer of the bidder not fulfilling the qualifying requirements will be rejected.
 5. The bidder will have to register themselves on website <http://www.eproc.rajasthan.gov.in> for participating in this tender. For this purpose Digital Signature Certificate (DSC) have to

be obtained from any agency approved by CCA. This DSC will be used to sign the bids submitted online by the bidder. Unsigned tenders will not be entertained and will be rejected out rightly.

6. The tender for supply shall remain valid for the period of 120 days from the date of opening of technical bid.
7. If any bidder withdraws his tender prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the tender within the said validity period, which are not acceptable to the RVUN, or fails to commence the work in the specified period/ fails to execute the agreement, the department shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any contractor, who having submitted a tender does not execute the agreement or does not start the work or does not complete the work and the work has to be put to re-tendering, he shall stand debarred from participating in such re-tendering in addition to forfeiture of earnest money/ security deposit and other action shall be taken as per agreement/terms & conditions of the contract/tender. If there is strong justification of believing that the bidder or his authorized person has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.
8. All tenders, in which any of the prescribed conditions are not fulfilled or which have been vitiated by errors in calculations, totalling or discrepancies in figures or words or other discrepancies, may be liable to rejection.
9. Conditional tenders shall not be accepted and will be liable to be rejected.
10. The department will not be responsible for any delay on account of late submission of tender due to online submission.
11. Physical submission of bids is not allowed.
12. The bidder shall ensure that scanned copy of all the schedules as asked in tender document have been filled up and attached with the bid submitted in electronic format.
13. The acceptance of the tender will rest with the competent authority who does not bind itself to accept the lowest tender, and reserves to itself the authority to reject any or all the tenders received without assigning any reason.
14. Tender fee / cost, e-tender processing fee are not refundable in any condition.
15. All other conditions shall be prevailing as detailed out in the tender document (in the respective sections/ volumes).
