QUALIFYING REQUIREMENT

The bidders participating in the tender enquiry for the work of excavation and loading of pond ash must fulfill the following qualifying requirements. The documents in support of qualifying requirements shall be submitted along with Part-A Bid:-

- a) Bidder should be a partnership firm or a company.
- b) The average turnover of the bidder for the last three financial years ending on 31.03.2019 should be at least 10 Crore/annum.

Note: -Balance Sheet

Audited balance sheets or Chartered Accountant certified showing the business turnover and profit & loss account for last three financial years of

the company on whose turnover qualification has been sought should also be submitted along with the proposal. (Individual or a partnership firm or a company not falling under statutory requirement of audit, has to submit a certificate from Chartered Accountant certifying the average turnover of the last three Financial Years indicating the year wise turnover i.e. FY 2016-17, 2017-18 & 2018-19).

- c) The bidder should have experience of executing similar work involving excavation, loading /unloading and transportation of coal/lignite/metal ore/lime/sand/ gypsum/ cement/gitti/soil etc. in a Government / Semi Government/ Central PSU/State PSU organization for minimum quantity of two lakh MT/ annum during last seven years from the date of opening of technical bid.
- d) Bidder should have PAN No., PF No., ESI No., GST registration No./ TIN No. & Labour License, as applicable. If any of the above Nos./ license is presently not available, then bidder will furnish an undertaking on Rs. 100/- Non Judicial Stamp Paper duly attested by Notary for submitting the same within one month from the date of issue of L.O.I.
