PQR for TN-484 (FF)

1. Bidder should have at least one year experience in operation of fire fighting system in any thermal power plant capacity of 110MW or more, during last five year& having single order more than 15 lacs.
2. Bidder should have solvency certificate of 50 % of estimated costof Tender i.e. Rs.10 lac issued by Nationalized Bank/Competent authority. Solvency certificate should not be more than three year old as on date of tender opening.
3. The bidders should furnish copy of GST registration with central excise department , PF registration, PAN card in the name of firm.
4. The bidder must have an experience of having successfully completed work for operationfire fighting system in power plant of having Units not less than 110MW capacity or more during last three years ending last day of month previous to the one in which bids are invited, should posses either of the following :-
 - a. Threesame completed work orders each costing not less than the amount equal to 40% the G - schedule value for one year.

Or

b. Two same completed work orders each costing not less than the amount equal to 50% the G - schedule value for one year.

Or

c. One same completed work orders each costing not less than the amount equal to 80% the G - schedule value for one year.

PQR for TN-485(CA-M)

1. The bidders should have GST registration , PF registration, PAN card, ESI registration and labour license (if required)
2. Bidder should have solvency certificate of 50 % of estimated cost duly issued by Nationalized Bank/ Competent authority. Solvency certificate should not be more than three year old.
3. Bidder should have at least one year experience of similar nature of work in related field executed with at least 50% estimated cost during last five year in any Govt./semi govt./public sector under taking/ reputed private industry.
4. Satisfactory performance certificate or its proof for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization.

PQR for TN-487(L&L)

1. The bidders should have average Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less than the amount calculated on prorata basis for 12 months of the

total estimated value of the work or be at-least 50% of the total estimated value of the work, whichever is higher.

2. The bidder should have an experience of having successfully completing similar works during last 7 years ending last day of the month previous to the one in which applications are invited and should be either of the following :-
 - a. Three similar completed work orders costing not less than the amount equal to 40% of the estimated cost or
 - b. Two similar completed work orders costing not less than the amount equal to 50% of the estimated cost or
 - c. One similar completed work order costing not less than the amount equal to 80% of the estimated cost.
3. The participating bidders should have GST registration, PF registration, PAN card, ESI registration and labour license (if required).
4. The bidders should submit Satisfactory performance certificate/work completion certificate for similar nature works executed by the firms and these should be signed by the order placing authority of the concerned organization and performance certificate for GLPL works issued on or after dated 01.11.2018 should be signed by the concerned Chief Engineer/Incharge of power station/project.
5. The bidders should submit an undertaking on Non - judicial stamp paper worth Rs. 100/- on original stamp paper (Photo copy will not be accepted) with the certificate mentioning in it that the firm has no liability in the concerned department regarding deposition of CPF , ESI & Service Tax/ GST etc. upto the period 31.03.2018.

Note: - 1.The technical evaluation of the bids shall be done on the basis of above criterions. The offers of the bidder not fulfilling above conditions fully or partially are likely to be ignored& rejected.


