Tender TN-480 to 483 shall be in two part bidding system having Part-A (Technical Bid) & Part-B (Price Bid) and TN-480 & 481 will be accepted through www.eproc.rajasthan.gov.in. but The Tender documents can be downloaded from www.sppp.rajasthan.gov.in and www.eproc.rajasthan.gov.in. Requisite tender cost, EMD and processing fees should reach on or before schedule date and time at the office of the Superintending Engineer (Proc.), Opposite new Power House, Indira Colony, Barmer. Without Requisite tender cost, EMD and processing fees tender will not open.

Tender TN-482 & 483 tender can be downloaded from www.sppp.rajasthan.gov.in or can be purchase from Office of SE (proc.) by depositing tender fee with application. Tenders TN-482 & 483 will accept off line, should received on schedule date and time with EMD & tender fee.

PQR for TN-481(Civil) & TN-482(Civil)

1. Average Annual Financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less equal to three amount calculated on prorata basis for 12 months of the total estimated value of the work or be at-least 30% of the total estimated value of the work, whichever is higher.
2. The bidder must have an experience of having successfully executed / completed the annual contract for similar nature works in any of the thermal power plant(s) / gas power plant(s)/ any process industries/any electrical utility/organization(Govt./reputed) during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s):
 - a. Three executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each
or
 - b. Two executed/completed contracts , as above, costing not less than the amount equal to 50% of the estimated cost each
or
 - c. One executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.
3. Satisfactory performance certificate or its proof for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization.
4. The participating bidders should have GST registration , PF registration, PAN card, ESI registration and labour license (if required)

PQR for TN-480(Elec.)

1. Average Annual financial Turn Over in the preceding three completed financial years as on date of bid opening should not be less equal to three amount calculated on prorata basis for 12 months of the total estimated value of the work or be at least 30% of the total estimated value of the work , whichever is higher.
2. The bidder must have an experience of having successfully executed/ completed the annual contract for similar nature works in any of the thermal plant(s)/gas power plants(S)/any process industries/any electrical utilities/organization (Govt. /reputed) during last 7 years ending last day of the month previous to bid opening date with either of the following executed value(s) of the contract(s)

a. Three similar executed/completed contracts, as above, costing not less than the amount equal to 40% of the estimated cost each

Or

b. Two similar executed/completed contracts, as above, costing not less than the amount equal to 50% of the estimated cost each

Or

c. One similar executed/completed contract, as above, costing not less than the amount equal to 80% of the estimated cost.

3. Satisfactory performance certificate or its proof for above executed works should be signed by officer not below the rank of Superintending Engineer or order placing authority of concerned organization.

4. The participating bidders should have GST registration with Central Excise Department, PF registration, PAN card, ESI registration and labour license (if required) and class A electrical license (if required).
PQR for TN-483 (P&A)

(a) Bidder should have solvency of more than estimated cost of tender. Solvency certificate should not be more than three year old.

(b) Bidder should have at least one year experience of similar nature of work in related field in any Govt./semi govt./public sector under taking/ reputed private industry and also produce duly attested copy of past work order, work completion certificate etc as proof of work experience.

Note: - 1. The technical evaluation of the bids shall be done on the basis of above criterions. The offers of the bidder not fulfilling above conditions fully or partially are likely to be ignored & rejected.

2. In compliance to Rajasthan transparency in public procurement Act 2012 and Rajasthan transparency public procurement rules 2013 the A to D annexure has been add in GCC. These will be part of GCC of contract .The bidders should go through these. The bidder should fill the annexure
